5. On the satisfactory discussion of all the above points, vote of thanks was extended by Prof. Achal Agrawal.

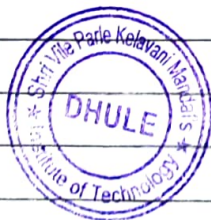
